Inclusion of Women Tennis in Central Sports Meet

8408. SHRI G. SWAMINATHAN; Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether it is a fact that Women Tennis is not tucluded in the Central Revenue Sprits meet;
 - (b) if so, the reason therefor; and
- (c) whether the Ministry is aware consequent to the same women Tennis players could not be recruited by the above department for any relevant post for which they are eligible?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF YOUTH AFFAIRS AND SPORTS) (SHRI MUKUL WASNIK): (a) Yes, Sir.

- (b) The events to be included in the Central Revenue Sports meet are decided by the Central Revenue Sports Board (CRSB). This event has not been included due to the fact that no request from he zones of the CRSB has ever come before the Board for organising this event, possibly because there are not enough participants to enable holding of the event.
- (c) The CRSB Organises Sports meet only for their employees. Not holding a Women's tennis tournament by the CRSB therefore does not adversely affect the entry of Women tennis players for eligible posts in the department in accordance with the normal recruitment rulee for Sportsper-sons under the Sports quota, for which action has to be taken by concerned heads of department.

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. OF CULTURE (KM. SELJA): (a) As per the revised pay structure notified by the Gov eminent in August, 1987, every teacher is entitled to a Senior scale and also a Selection scale subject to "ul-filment of certain conditions.

(b) and (c) The main recommendation of the Committee related to the introduction of elective subjects at the +2 stage which would require •dclitional teaching posts at the higher level thereby providing some opporunity for promotion to the existing teachers in the subject. However, introduction of additional elective subjects in all Kendriya Vidyalayas would require substantial additional funds. Keeping in view the present resource constraints, it has been decided to start "Introductory Computer" in Class XI in 20 Kendriya Vidyalayas under Civil and Defence Sectors
