#### **Air India tie-up with Damania Airways**

Will the Minister of **CIVIL AVIATION AND TOURISM** be pleased to state:

(a) whether Damania Airways has signed some interline agreement with Air India in the recent past;

(b) if so, the details thereof with objectives;

(c) whether such agreement will benefit the country in any way; and

(d) if so, the details thereof and if not, the reasons therefor?

**THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI GHULAM NABI AZAD):** (a) to (d) Yes, Sir. Air India has signed a unilateral passenger interline agreement with Damania airways on 10.4.1995. Under this arrangement Damania airways honours Air India tickets on their domestic network and Air India pays Damania airways in rupees for this transportation. The following advantages would accrue to Air India and its passengers:—

- Conservation of foreign exchange by Air India as payments to Damania would be made in rupees.
- Better choice of domestic connections to passengers.
- Reduction in airport halt period between international and domestic flights.
