(a) to (c) During the post liberalisation! period, Industrial Entrepreneur Memoranda (IEMs) envisaging an invest, ment of Rs. 39,099 crores have been received upto March, 95 for setting up of food processing industrirs Out of these, 268 IEMs envisaging an investment of Rs. 2592 crores have been received from the State of Madhya Pradesh. Apart from these, 587 proposals envisaging an investment of Rs. 7679 crores including foreign investment of Rs. 2528 crores have been approved for setting up of 100 per cent Export Oriented|JoiniQ Venture'Industrial Licence food (processing units. Out of these, 15 proposals envisaging an investment of Rs. 151 crores including foreign investment of RS. 9 crores have been approved-for the state of Madhya Pradesh. Normally, it takes 2-3 years for implementing the project.
