Production of traditional varieties of Rice

5638. SHRI YERRA NARAYANA-SWAMY: Will the Minister of AGRICULTURE be pleased to state:

(a) whether there is any proposal to ensure that traditional varieties of rice are grown in India;

(b) if so, the details of schemes to encourage farmers to continue cultivation of traditional rice varieties;

(c) whether any funds are available for this purpose; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARVIND NETAM): (a) There is no proposal to ensure that only traditional varieties of rice are grown on commercial scale, other than to ensure the conservation of such genetic stock of traditional rice varieties on a systematic way so as to be useful for future breeding programmes.

Criteria for the Allotment of Houses to Fishermen

5639. SHRI SANATAN BISI: Will the Minister of AGRICULTURE be pleased to state:

(a) the criteria for the allotment of houses to the families of fishermen under the Scheme of Model Fishermen Village; and

(b) the target under the scheme of 'fishermen village' for the year 1995-96, State-wise?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI S. KRISHNA KUMAR): (a) and (b) National Welfare of Fishermen Scheme has three components, one of which is 'Development of Model Fishermen's Village', under which there is provision for construction of houses for the fishermen. The allotment of houses to the fishermen under this component has been left to the concerned State Government. Under the scheme, the annual target is fixed in terms of number of villages to be developed in the Country and no State-wise targets are fixed. The target for 1995-96 is for development of 26 Model Fishermen's Villages.
