- (b) whether it is a fact that the Anganwadi workers are paid only Rs, 350/- p,m.;
- (c) whether it is also a Yact that Government are treating the Anganwadi workers and helpers as honorary and part-time workers; and
- (d) whether Government propose to give any assurance to the trade unions of these Anganwadi workers in response to their recent strike, if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT) (SMT. BASAVA KAJESHWARI): (a) No Sir.

- (b) Honorarium paid to the Anganwall workers varies from Rs. 350/- to Rs. 450/- per month depending on qualifications possessed by them,
  - (c) Yes, Sir.
- (d) Associations of Auganwadi workers have been demanding the status of Government employees the scales and allowances as admissible to Government employees. Anganwadi workers are part-time honorary workers drawn from the local community. In view of the voluntary nature of their work, it is not possible to appoint them as Government servants of offer them the regular pay scales. The proposal for revision of their honorarium is under consideration of the Government. In view of above the question of giving any assurance to the Trade Unions in this regard does not arise.
