develop transmission system, financial assistance through Accelerated Power Development Programme (APDP) for strengthening of sub transmission and distribution as well as for renovation and modernisation of old thermal and hydel power plants.

### Amount allocated under Rural Water Supply Programme

†1283. SHRI MANOHAR KANT DHYANI: Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the State-wise amount allocated under Rural Water Supply Programme and, 'Pradhanmantri Gramoday Yojana' during 1999-2000 and 2000-2001;
- (b) whether issues relating to quality and not getting the desired results have come up before Central Government in this regard and if so, the reaction of Government thereto; and
- (c) whether there is any proposal to frame rules for fixing up of responsibilities towards schemes and people's participation with the Governments of the States?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT [DR. (SHRIMATI) RITA VERMA]: (a) Drinking water supply being a State subject, the schemes for supply of safe drinking water to the rural habitations of the country are implemented by the State Governments under the State sector Minimum Needs Programme (MNP). The Central Government supplements the efforts of the States by providing funds under the Accelerated Rural Water Supply Programme ((ARWSP). The powers to plan, sanction and implement individual rural water supply schemes have been delegated to the State Governments. A statement indicating funds allocated under the ARWSP and the provision made under MNP by the State Governments for Rural Water Supply Programme during 1999-2000 and 2000-2001 is at statement-I (See below). Further, Central funds are also provided to the States as Additional Central Assistance (ACA) under Prime Minister's Gramodaya Yojana (PMGY)-Rural Drinking Water from the year 2000-2001. PMGY provides assistance to five sectors namely, Primary Education, Primary Health, Rural Shelter, Rural Drinking Water and Nutrition. An amount of Rs. 2,500 crore has been provided as ACA for these five sectors. A minimum of 15% of the total ACA to each of these five sectors has been provided. States/UTs are required to decide about the remaining 25% of the allocation among the five sectors. A statement indicating the funds allocated under PMGY-Rural Drinking Water during the

year based on a minimum 15% allocation, is at Statement-II (See below).

- (b) As per the reports received from the State Governments, about 2,17,000 rural habitations of the country were affected with water quality problems as on 1.4.1999. The State Governments can utilise upto 20% of ARWSP funds for planning and implementing Sub-Mission Projects to tackle the problems arising due to water quality. The powers to plan, sanction and implement such projects have also been delegated to the State Governments since 1.4.1998.
- (c) Reforms have been introduced in selected districts on pilot basis in the rural water supply sector to institutionalise community participation in the programme by empowering the rural community to plan, sanction, partially fund, implement, manage, operate and maintain rural water supply schemes of their own choice.

## Drought in Andhra Pradesh

1284. DR. DASARI NARAYANA RAO: Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) how many rural blocks are currently under the impact of drought in Andhra Pradesh, district-wise;
- (b) whether it is a fact that Employment Assurance Scheme and other drought relief measures are not being implemented in these areas in full scale; and

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (DR. (SHRIMATI) RITA VERMA): (a) to (c) The Central Government have not received any report from the Government of Andhra Pradesh on the deficiency of rainfall during the last South-West Monsoon period in the State leading to drought conditions.
