- *t 81.* SHRI YERRA NARAYANA-SWAMY: Will the Minister of COM-MERCE be pleased to state:
- (a) whether the Tobacco Board is to be re-constiluted shortly:
- (b) if so, whether growers from West Godavari district and East Godavari district will be considered for representation;
- (c) whether there is a demand to enhance the activities of the Tobacco Board so as to help farmers; and
 - (d) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF COMMERCE (SHRI P. CHIDAMBARAM): (a) The appointment col 11 official members and one elected mebers of the Rajya Sabha has already been notified. Ten members representing growers, dealers, manufacturers, exporters and experts in agricultural economics/tobacco marketing, two members on rotation basis of the Governments of tobacco growing sta-

tes other than Andhra Pradesh, Karnataka and Gujarat and two members from the Lok Sabha have yet to be appointed to the Board.

- (b) Yes, Sir.
- (c) and (d) Yes, Sir. Suggestions have been received in regard to:—
 - (i) bringing of Non-Virginia tobacco under the purview of the Board.
 - (ii) enhancing production targets for FCV tobacco in Karnataka, increased supply of fertilizer and pesticides at subsidised rates, coverage of tobacco under crop insurance scheme, adoption of measures for Welfare of growers and promotion of export.

Intportof Edible Oil under OGL

- *83. SHRI GHUFRAN AZAM: Will the Minister of COMMERCE be pleased to state:
- (a) whether Government have allowed import of edible oil under OGL;
- (b) whether Government have made any estimate of production of edible oil before allowing imports of edible oil under OGL;

THE MINISTER OF STATE OF THE MINISTRY OF COMMERCE (SHRI P. CHIDAMBARAM): (a) to (d) Keeping in view the demand and supply position import of all edible oils excluding Coconut Oil, Palm Kernel Oil, RBD Palm oil and RBD Palm Stearin has been permitted freely vide Ministry of Commerce Notification No. 54(RE)/ 92-97 dated 1-3-1995, copy of which is available in the Parliament Library. Besides augmenting the availability of edible oils to the consumer, competition from imported edible oils will ensure that domestic prices do not rise beyond the landed prices of the imported oils, inclusive of customs duty.
