THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI K. P. SINGH DEO): (a) No, Sir. The programme is of half an hour duration on Saturdays and Sundays and one hour duration on the remaining days.

- (b) The programme is produced by a private limited company registered under the name of Dee's Marketing Pvt. Limited, New Delhi.
- (c) under the agreement, Doordarshan is paid a telecast fee of Rs. 5000/- per half an hour in addition to 50 per cent of the revenue earned from the programme.
- (d) The sponsorship fee for half an hour slot on DD-2 varies between Rs. 2.6 lakhs to Rs. 20 thousand
- (e) No Sir. The programme is being telecast with the approval of the Competent Authority.

Providing C Band system in Gujarat

SINGH DEO): Besides DD-1 (Primary National channel) and DD-2 (Regionat Service in Gujarat) which are available terrestrially in the service area of all the transmitters functioning in the State of Gujarat, DD-2 service is being relayed by tecrestrial transmitters functioning at Ahmedabad and Gandhinagar. However, all the channels of Doordarshan are available for viewing with the help of a suitable dish antenna in all parts of Gujarat.
