1833, SHRI JIBON ROY: Will the Minister of STEEL be pleased to state:

- (a) whether it is a fact that the Durgapur Steel Plant is likely to suffer a loss of about Rs. 30 crores in the current financial year due to cut down order of 'Wheel and axles by the Railways; and
- (b) if so, the steps taken by his ministry to resume the cut down order?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV): (a) Durgapur Steel Plant is likely to suffer a loss of about Rs. 26 crores during the current financial year due to cut down order of Wheel & Ax'es by Railways

(b) Ministry of Steel is making continuous efforts to pursuade the Ministry of Railways to step up their procurement of Wheel & Axles from the Wheel & Axles Plant, Durgapur having regard to the fact that the plant has been modernised at a total cost of Rs. 142.77 crores mainly with the objective of catering to the requirements of Railways.

Rules 1963, Government may relax all or any of the provisions of Allotment Rules in case of any officer or residence class of officers or type of residences. Under this provision the competent authority sanctions ad-hoc allotment at his her discretion taking account the service conditions and family circumstances of the officer concerned. Such allotments are generaly made in one below the entitled types.
