sanctioned staff to Vidyalayas keeps varying with addition[reduction in the number of sections upgradation of Vidyalaya, addition or withdrawal of streams at +2 level, change in norms of staff fixation etc. The teachers who became supernumerary are adjusted against the vacant posts during annual transfers as per the transfer guidelines and this is a continuing process.
