

Literacy in Hindi speaking areas

1792. SHRIMATI VEENA VERMA:
Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether Government have decided to accord high priority to improve the literacy rate in the Hindi heartland (BIMARU), Bihar, Madhya Pradesh, Rajasthan and Uttar Pradesh;

(b) if so, whether any comprehensive plan has been prepared in this regard; and

(c) if so, the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. OF CULTURE) (KM. SELJA): (a) to (c) The National Literacy Mission has been mandated to make 100 million people literate in the 15-35 age group by 1997. No separate year-wise or State-wise targets have been fixed. The main approach towards literacy is through volunteer based Total Literacy Campaigns. The focus of the National Literacy Mission is now on the 4 States of Bihar, Madhya Pradesh, Rajasthan and Uttar Pradesh where according to 1991 census 48 per cent of the illiterate population aged 7 years and above reside. Of the 335 districts taken up to for under the Total Literacy Campaigns, 124 districts are in these 4 States.

SELJA): (a) and (b) Out of the thirteen Central Universities only one University viz. Visva-Bharati is functioning under Acting Vice-Chancellor, because the Vice-Chancellor has resigned. The resignation of Vice-Chancellor of Visva-Bharati was accepted on January 31, 1995. Government has initiated steps for filling up this vacancy as per the provisions of the Act and Statutes of Visva-Bharati.
