

Criteria for selection of sports persons

1777. DR. SANJAYA SINH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) the details of the criteria adopted for the selection of sports persons for various sports events on the National and International level; and

(b) what steps have been taken to ensure fair selection of sports persons?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF YOUTH AFFAIRS AND SPORTS): (SHRI MUKUL WASNIK): (a) The main criteria for selection of sports persons for various sports events at the national and international level is the present performance of the sports persons and the standards of competing nations. For important international events such, as Asian/Commonwealth and Olympic games specific qualifying standards are laid.

(b) Government has been emphasising upon the Federations to have fair and transparent procedures for selection. A Selection Committee consisting of the President of the Federation, IOA representative, Government nominee, nominee of Sports Authority of India and the National Coach select the teams/sports persons. Before approving the participation in international sports events abroad, Government insists on scrutinising the minutes of the Selection Committee.

Scheme for giri child

1778. SHRI IQBAL SINGH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a). whether Government have formulated a new scheme for the giri child for her higher studies, starting economic ventures or for her marriage in the country particularly in the State of Punjab;

(b) if so, the details thereof, State-wise; and

(c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF CHILD DEVELOPMENT) (SMT. BASAVARAJESHWARI): (a) to (c) The Government of India has not formulated, any such new scheme. However, the State Governments of Haryana and Tamil Nadu have launched scheme for the Girl Child. The details are given in the enclosed Statement (*See below*). As regards Punjab no such scheme has been launched.

Statement

HARYANA

The Scheme 'Apni Belt' 'Apna Dhan' launched by Haryana Government provides for an investment of about Rs. 3,030/- per child as an instrument of small savings at the time to birth of a female child in all families below the poverty line and SC families (except income tax payees and families where either parent is a Class I or Class-II Officer). It has also been provided that the benefit of the Scheme will be available, to families having their first or second or third child. The amount invested will comprise of Rs. 2,500/- in small savings instrument which will mature after 18 years and Rs. 500/- in cash to be paid to the mother on birth of a girl child for her nutrition and medical expenses.

TAMIL NADU

The State Government of Tamil Nadu has launched a specific scheme called the Puratchi Thalaivi Dr. Jayalalitha Scheme for the giri children as a specific measure to prevent female infanticide. The scheme envisages to help girl children of poor families and simultaneously convince the people to adopt the small family norm. The eligibility criteria for the scheme are as follows:—

- (1) One of the parents should have undergone sterilisation on or after 01.04.1992;
