(b) The Guwahati University has informed that all these for the Ph.D. degree to be awarded by the University are to be written in English. Howeer, these on Assamese language and culture are allowed to be written in Assamese also. This is considered desirable as it enables teachers, scholars and students of all languages to read and understand the contents of the theses. According to the University, a Ph.D. candidates should have adequate knowledge of English to be able to write the thesis in this language.

(c) Universities are autonomous organisation established by the Acts of Parliament or the State Legislatures. All decisions on academic matters are taken by the Universities themselves in accordance with the provisions in the Acts and Statutes of these Institutions.
