SELJA): (a) Kendriya Vidyalaya Sangathan is an autonomous organisation under the Ministry of Human Resource Development fully financed by the Govt. of India and is implementing the Pay scales as fixed by Govt, of India from time to time.

Transfer of Navodaya Vidyalaya Teachers

Navodaya Vidyalaya Samiti has informed that frequent transfers of teachers adversely affect, the teaching|learning process and other activities of Navodaya Vidyalayas especially since they are residential schools. It was therefore decided that transfer reqesfs against vacant posts should be accepted where justified and an employee would be given only one opportunity for request, transfer through, out his tenure.

(c) and (d) The demand for introduction of new elective subjects in Vidyalayas at +2 stage is under consideration by the Kendriya Vidyalaya Sangathan.
