Newspapers Published in Different Languages

- 3439. SHRI MOHAMMED AFZAL alias MEEM AFZAL: Will the Minister of INFORMAITON AND BROADCASTING be pleased to state:
- (a) the language-wise number of Newspapers published in 1994: and
- (b) the circulation of each' of the newspapers?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BRADCASTING (SHRI K.P. SINGH DEO): (a) The Information relating to total number of newspapers published in the country is not available as the Registrar of Newspapers for India (RNI) maintains information only in respect of newspapers registered with them who submit their Annual Statement in terms of PRB Act. 1867. However, 38,800 newspapers were registered with RNI as on 31.12.1994

.(b) The .Annual Statements for the year 1994 submitted by the newspapers are under scrutiny. Compilation of circulation data etc. will be completed by RNI by 30th September, 1995 by which date they are required to sumit their Annual Report 'Press in India' to the Government.

Indian Languages Newspapers Association

3440. SHRI RAMDAS AGARWAL: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether the Indian Languages Newspapers Association (ILNA) have urged Government to reserve 200 tonnes of indigenous newsprint for each small and medium newspaper in the country at reported in the news item published in! the Hindustan Times dated 7.4.95 (page S) captioned "ILNA demands Newsprint quota":
- (b) if so, what are the details thereof including their demand to increase the advetisement. tariffs and expenditure payemnt. by DAVP; and'
- (c) if so, what action Government have taken so far in this regard and if not. the reasons therefore?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BRADCASTING (SHRI K.P. SINGH DEO): (a) The Government do not seem to have received such a. demand from the Indian Languages Newspapers Association (TLNA).

(b) and (c) The Government have decided to increase the advertisement rates of DAVP with effect from April 1, 1995. DAVP have also been told to settle the pending advertisement bills expiditionsly.

Export potential of Indian films

- 3441. SHRI RAMDAS AGARWAL: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) whether it is a fact that Indian films account for about one fifth of the world's total production but India's presence in the international market is only 0.1 per cent as reported in a news item published in the Hindustan Times dated 3rd April, 1995;
- (b) if so, the reasons therefor and the steps taken by I & B Ministry to exploit the export rotential of Indairi films and other entertainment software which are not only popular abroad but also in great demand;
- (c) whether Government have any proposal to convert the National Film and Development Corporation (NFDC) into a film export Fromotion Council instead of its playing the role of a cultural patron apart from its collaboration with Doordarshan for Co-production of a large number of films with Doordarshan;
- (d) whether NFDC's direct export of films from Rs. 208.18 lakh in 1992-93 declined to Rs. 133.25 lakh in 1993-94 and video cassette marketing showed a decline by 50 per cent as compared to previous year; and
- (e) if so, what steps/action have been taken by Government for greater overseas sale of video rights of films and exploring new markets such as TV channels, Pay TV, Satellite Broadcasts and Cable TV etc?

- THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI K. P. SINGH DEO): (a) No authentic statistics in this regard are available. It is, however, understood that these estimates published in a news items in the Hindustan Times are based on information from trade magazines.
- (b) The Government of India has decanalised the export of films from 14-9-91 to remove any constraints on their successful exploitation abroad.
- (c) The proposal to accord NFDC the status of an Export Promotion Council (EPC) for films has not materialised so far due to Government's policy to phase out financial support to EPCs.
- (d) and (e) Yes, Sir. It is true that the NFDC's film exports have declin. ed from Rs. 208.18 lakhs in 1992-93 to Rs. 133.25 lakhs in 1993-94.. This is due to decanalisation. However, total export of films from the country have increased from Rs. 16 crores in 1991-92, before decanalisation to Rs. 22 crores in 1993-94. It is also a fact that marketing of video cassettes by NFDC has declined due to technological advances to allow viewers other options to video cassettes like foreign satellite chanenls, cable TV etc
