(b) and (c) Against a quantitative coiling of 3 lakh MTs of Durum wheat and 5 lakh MTs of Non-Durum wheat fixed for the year 1994-95, 17,058 MTs of wheat (Durum & Non-Durum) valued at Rs 10.91 crores has been exported during the period April-December, 1994.

Decline in exports to European countries

Will the Minister of COMMERCE be pleased to state:

- (a) whether exports of several Indian items to Europe has fallen at the end of last year and trade with European countries is in danger of declining as reported in the 'Pioneer' dated January 14, 1995;
- (b) if so, what are the facts and details in this regard;
- (c) what are the reasons for fall in exports to Europe;
- (d) what is the quantum of annual exports and imports to and from Europe during 1991-92, 1992-93 and 1993-94 and so far in 1994-95; and
- (e) what steps Government have taken or propose to take to boost trade with the European countries and what is the impact of these steps?

THE MINISTER OF STATE OF THE MINISTRY OF COMMERCE (SHRI P. CHIDAMBARAM): (a) to (c) During the period April-December, 1994, the percentage growth in aggregate exports from India to Europe was 16.68% as compared to the corresponding period in 1993. The growth of aggregate exports includes marginal decline in exports of some items and increases in respect of others which is a normal feature.
