Abduction of Indian Fishermen by the Pakistani Maritime Agency

SHRI PRAMOD MAHAJAN:

Will the Minister of EXTERNAL AFFAIRS be pleased to refer to answer to Unstarred Question No. 2203 given in the Rajya Sabha on December 21, 1994 and state:

(a) how, when and from where the Indian fishermen and their boats were abducted by the Pakistani Maritime Security Agency and what are the details in this regard;

(b) what steps Government have taken so far for the release of Indian fishermen and their boats from the Pak custody and with what results;

(c) the number of Indian fishermen and their boats released so far and how many fishermen and their boats are still in Pak custody and by when they are likely to be released;

(d) how many times there have been violations of the Indian territorial waters by the Pakistani Coast Guards, Navy and Marine Security Forces, by taking away with them Indian fishermen and their boats during each of the last three years and so far in 1995, and what are the details thereof; and

(e) what steps Government have taken or propose to take to check the Pakistani piracy into Indian territorial waters of Gujarat, Saurashtra and K'tch?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI PRANAB MUKHERJEE): (a) to (e) Incidents of harassment and capture of Indian fishermen by Pakistani Security Agencies occur periodically, off the Coast of Gujarat, close to the national Maritime boundary which has not been finalised yet.

There were no incidents of capture of Indian fishermen in 1992. In 1993 and 1994, Pakistan captured 16 fishing boats with 106 fishermen, and 32 fishing boats with 195 fishermen respectively. So far, in 1995, according to available information, 4 boats with 19 Indian fishermen were taken into custody by Pakistan.

Following reports of capture, Government immediately take up the matter of early release and repatriation of all Indian fishermen in Pakistan's custody with the Government of Pakistan. The last exchange of fishermen between India and Pakistan took place in January 1995 when Government secured the: release of 27 Indian fishermen and 5 Indian fishing boats.

According to available information, at present there are 187 fishermen and 31 fishing boats in Pakistan's custody. Government have taken up with Pakistan the matter of early release and repatriation of these Indian fishermen and modalities are being worked out through diplomatic channels.

Government have also taken up with Pakistan through diplomatic channels, the matter of the safety and security of Indian fishermen.

Regular and continuous patrolling of our territorial waters off the Coast of Gujarat is being maintained by the Coast Guard as a measure of constant vigil and to prevent any intrusions by Pakistan even though there have been no incidents of violation of our territorial waters as such in the recent period.
