

However at present ten new projects each costing Rs. 20 crores and above with a capacity of 16.71 million tonnes per annum are under various stages of implementation in ECL.

As regards complaints, coal companies have set up a procedure for redressal of grievances. Regional Coal Consumers Councils have been set up in each subsidiary of Coal India Limited.

Electronics and Computer Software in Thrust Sector to export

*756. SHRI B. K. HARIPRASAD:
Will the Minister of COMMERCE be pleased to state:

(a) whether it is a fact that Electronics and Computer Software have been identified as thrust sector for export;

(b) how many electronics and computer software units are in operation under the EOU Scheme in the country and how many of them are located in Bangalore/Karnataka; and

(c) how many Export Processing Zones have been set up in the country and whether despite being a leading city for exports of leather garments, silk, handicrafts, agarbathi/incense/perfumes and electronics and computer software, Bangalore is still to have its own Export Processing Zone and if so the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF COMMERCE (SHRI P. CHIDAMBARAM): (a) Yes Sir,

(b) At present, there are 66 Electronics and Computer Software units in operation under the EOU scheme in the country. Out of them 13 units are located in Karnataka including 12 units in Bangalore,

(c) At present, there are 7 Export Processing Zones (EPZs) functioning in the country. These are at Santacruz (Maharashtra), Kandla (Gujarat), Noida (UP), Madras (T.N.), Cochin (Kerala), Falta (W. Bengal) and Visakhapatnam (A.P.)
