You him say whatever he wants to say. are creating a rumpus here. He is trying to explain his viewpoint. He has the right. One has to listen to each other's viewpoint. I have to listen to his point of order and deal with it. It is not proper that only what you want should be done and the others cannot have their say. Please. You are sitting in a big House. I do not want to give a sagain. Please. I am to saying anything.
