

(c) As on the date of the Supreme Court Judgement, only 14 States namely Andhra Pradesh, Assam, Bihar, Goa, Gujarat, Haryana, Himachal Pradesh, Karnataka, Kerala, Maharashtra, Madhya Pradesh, Tamil Nadu and U. P. had notified lists of OBCs for the purpose of reservation in State Government services. Accordingly, those of the State Governments which did not notify lists of OBCs, were requested by the Ministry of Welfare to notify the lists of OBCs so that the OBCs population in those states are not deprived of the benefits of reservation.

The States of Rajasthan and Orissa have notified the lists of OBCs on September 1 and September 22, 1993 respectively. Sikkim has also identified the OBCs. The State Govts. of Nagaland & Arunachal Pradesh have intimated that they have no OBCs population, the matter is being pursued with the other State Governments.

(d) Most of the Election Manifestos of political parties for the General Election, 1991 contained a promise regarding implementation of Mandal Commission's recommendations regarding reservation for the backward classes. It is, therefore, pre-said that the recommendation by and large had the support of the majority of people.

(e) and (f) In regard to the provision of reservation in promotions for Scheduled Castes/Scheduled Tribes, the Welfare Minister made a statement in the House on 23rd December, 1992 and assured that there would be no immediate disturbance of the present dispensation regarding promotions for SCs/STs. The Department of Personnel & Training have issued instructions on 19th August, 1993 to all the Ministries/Departments to ensure that the existing provisions of reservation for SCs/STs in the matter of promotion are implemented without fail.
