Parking of Boeing 1Z1 at Nagpur Sonegoan Airport

323. SHRI V. GOPALSAMY:

Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state;,

- (a) whether it is a fact that a Boo ing 727 was allowed to be parked at Nagpur Sonegoan Airport in the past; if so the date on which it landed at the Airport;
- (b) how old the Boeing is as on date;
- (c) whether the Director General Civil Aviation has initiated any steps to recover outstanding dues accrue.! on account of Inland Air Travel Tax. if so, what is the amount and wsbe i the same was recovered from the concerned;
- (d) whether any dues are to be paid to National Airport Authority by the concerned for halting charges; if so, the details thereof; and
- (e) when the NAA has received the amount; if not what steps are be, ing initiated to recover the dues from the concerned?

THE MINISTER OF CIVIL AVIATION AND TOURISM (SHI,! GHULAM NABI AZAD): (a) and (b) A B-720 aircraft operated by M/s. Continental Aviation Pvt. Ltd. was allowed to make precautionary landing at Nagpur Sonegon airport due to engine failure on 21.7.91. Th₃ aircraft is approximately 31 years old.

- (c) The Inland Air Travel Tax is collected by the airlines and remitted to the Central Exchequer,
- (d) Yes, Sir. The airlines is to pay a sum of Rs. 11.47 lakhs as parking charges and Rs. 2.75 lakhs as interest on delayed payment. Besides the airline also owes a sum of Rs. 3.34 lakhs on *account of* Route Navigation facility charges, landing charges etc.

(e) The airlines has wound-up its operations. A civil suit is being filed in the Bombay High Court for recovery of the dues.

Operation of Gulf Airlines
