Closure of H.E.C., Ranchi

371 SHRI RAHASBIHARI BARIK: Will the PRIME MINISTER be pleased to state:

- (a) the reasons for the closure of Heavy Engineering Corporation (HEC), Ranchi;
- (b) whether any steps are being taken by Government for the revival of HEC;
- (c) if so, the funds required by HEC for its revival: and
- (d) the details of financial provision made by the Centre for the revival of HEC?

THE MINISTER OF STATE THE MINISTRY OF INDUSTRY (DEPARTMENT OF INDUSTRIAL PEVELOPMENT) AND MINISTER OF STATE IN THE MINISTRY INDUSTRY (DEPARTMENT OF HEAVY INDUSTRY) (SHRIMATI KRISHNA SAHI): (a) Heavy Engineering Corporation Ltd. (HEC) Ranchi has not been closed.

- (b) and (c) The company had formulated a Turn Around Plan (TAP) which envisaged fund assistance of Rs. 198 crore (Rs. 70 crore for capital expenditure and Rs. 128 crore as equity) besides VRS and financial restructuring. The TAP was examined by IDBI, the Operating Agency appointed by the BIFR. However, the same has not been accepted by BIFR. rehabilitation that the stating package, formula ed by IDBI was not viable. HEC is in the process of finalising an alternative plan for revival of the unit...
- (d) As the revival plan has not yet been finalised, the question of any financial provision to that effect does not arise.
