The estimated value of above quantity is Rs. 1,19,28,388 calculated at existing central issue price of rice. These stocks were rendered sub-standard due to progressive deterioration during long storage in depots. Mode of disposal of these stocks is to be decided on receipt of final orders from the Hon'ble Supreme Court as the matter is sub-judice,

#### **Measuring FCI truck loads of rice**

521. DR. NAUNIHAL SINGH: SHRI GAYA SINGH: SHRI JALALUDIN ANSARI:

Will the Minister of FOOD be pleased to state

(a) whether it is a fact that several truck loads of rice despatched from the Food Corporation of India (FCI) godowns in Jalandhar and Ludhiana districts are missing; if so, the details thereof;

(b) whether it is also a fact that consignment sent to the valley in early 1990 from the above mentioned districts had not been acknowledged by the Consignee; if so, the details thereof;

(c) whether 1400 metric tonnes rice despatched this year in trucks from Ludhiana district had ended up in the Delhi market; if so, the details of action taken by Government in the matter; and

(d) what steps Government have taken so that the above mentioned racket may not happen again in future?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD (SHRI KALP NATH RAO): (a) to (d) Information is

being collected and will be laid on the Table of the House.

#### **Delicensing of sugar industry**

(b) if so, what is its likely overall impact on the cooperative sector and the new units coming in this sector; and

(c) whether delicensing of sugar industry is likely to affect the prices of sugar and production of sugarcane?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD (SHRI KALP NATH RAO): (a) to (c) The option for delicensing the sugar industry in the country is presently under consideration of the Government, keeping in view the views of Cooperative Sector, Public Sector and Private Sector and also its impact on production prices etc.
