

**No-source villages in Stats**

1471. DR. B. B. DUTTA: Will the PRIME MINISTER be pleased to state;

(a) the State-wise number of no-source hard-core villages by the end of March, 1994;

(b) whether any target has been fixed to provide safe drinking water in these villages; and

(c) how Government propose to augment supply of safe drinking water in partially covered villages?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (DEPARTMENT OF RURAL DEVELOPMENT) (SHRI UTTAMBHAI PATEL): (a) There were 278 no-source hardcore villages in the country as on 31.3.94 as per the details given below: —

(c) In order to accelerate the coverage of all 'no source' and 'partially covered' villages, the outlay for the VIIIth Five Year Plan has been stepped up substantially to Rs. 5100 crores under Central Sector and Rs. 4954.52 under MNP (State sector). With this increased outlay,

all remaining no source villages and most of the partially covered villages are targeted to be covered by the end of VIIIth Five Year Plan.

**Water supply schemes in Orissa**

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (DEPARTMENT OF RURAL DEVELOPMENT) (SHRI UTTAMBHAI PATEL): (a) Following programmes are being implemented in the rural areas of Orissa State;

(i) Centrally Sponsored Accelerated Rural Water Supply Programme (ARWSP).

(ii) Minimum Needs Programme in State Sector.

(iii) Rural Water Supply Programme under Danida assistance.

(iv) Mini-mission completion of spill over items;

(v) Sub-Mission-iron removal.

(c) and (d) Yes, Sir. The allocation under ARWSP for 1994-95 has been increased to Rs. 24.34 crore as against Rs. 21.60 crore in 1993-94.
