

This includes provision of Rs. 500.00 crores for implementation of Voluntary retirement Scheme (VRS) in Central Public Sector Undertakings, Rs. 150.00 crores for workers' compensation packages in case of closure/rehabilitation was VRS in State PSUs and Rs. 50.00 crores for workers retraining, redeployment schemes, etc. As on 31.10.94, a sum of Rs. 44.40 crores was released for Voluntary Retirement Scheme of Central PSUs and Rs. 0.40 crores for workers retraining, redeployment schemes. The funds for Voluntary Retirement Scheme are to be utilised by Central Public Sector Undertakings including those located in Maharashtra and Madhya Pradesh, while those for worker retraining programmes are to be used by Employee Assistance Centres, including those in Maharashtra (at Bombay) and Madhya Pradesh (at Indore).

#### **Unsaleable material of Hindustan Paper Corporation**

1399. SHRI O. P. KOHLI: Will the PRIME MINISTER be pleased to give the answer to Unstarred Question 2401 given in the Rajya Sabha on 11th August, 1994 and state:

(a) whether there is a proposal to open a depot at New Delhi to keep certain level of stock of common variety required for use in the Government offices to be sold either directly or through the Super Bazar, Kendriya Bhandar, N.C.C.F. Government of Delhi or through its locally-appointed dealers for this purpose only:

(c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SMT. KRISHNA SAHI): (a) to (c) Hindustan Paper Corporation Limited already has a Depot-cum-Region Office at Delhi. Hindustan Paper Corporation is keeping com-

mon variety of paper in stock at godowns for supply to Government Offices either directly or through Super Bazar, Kandriya Bhandar, NC-CF etc. depending upon receipts of orders from these agencies. Supplies are made at approved price and policies of the Corporation. Where small quantity is involved Hindustan Paper Corporation's local stockist also cater to the requirements of these Government agencies to orders placed on them directly.
