Air Services from Gaya in Bihar

1348. SHRI NARESH YADAV: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

(a) whether it is a fact that a large number of foreign tourists visit Gaya in Bihar;

(b) whether it is also a fact that there is a major airport at Gaya; and

(c) if so, whether Government are seriously contemplating over the expansion of Gaya Airport and to introduce service from there with a view to earn foreign exchange?

THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI GHULAM NABI AZAD): (a) Yes Sir,

(b) Gaya has an airport which can accommodate AVRO type aircrafts.

(c) There is no proposal at present for the expansion of Gaya airport.

Aerodrome and air strips in Himachal Pradesh

1349. SHRI KRISHAN LAL SHARMA: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

(a) the number and location of aerodrome and air strips in Himachal Pradesh as on date alongwith their service conditions;

(b) whether it is a fact that the resource crunch has held up the modernisation and construction of aerodromes and air strips in that State;

(c) whether it is also a fact that tourists visiting Himachal Pradesh have complained of lack of infrastructure and high transport charges and also of water scarcity; and

(d) if so, what steps are being contemplated to meet such situations?

THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI GHULAM NABI AZAD): (a) National Airports Authority (NAA) has 3 airports in Himachal Pradesh located at Gaggal, Bhuntar and Shimla. All these airports are operational.

(b) No, Sir. Development of airports and other infrastructural facilities is a continuing process and is taken up in a phased manner, depending upon projected requirements and availability of resources.

NAA has undertaken developmental works at Gaggal. Due to difficult terrain at Shimla and Bhuntar, it has not been found feasible to upgrade these airports.

(c) and (d) Improving of tourists facilities is primarily the responsibility of the concerned State Government.
