#### **Monitoring Cell to watch availability of fertilizers**

1326. SHRI AJIT P. K. JOGI: Will the Minister of CHEMICALS AND FERTILISERS be pleased to refer to answer to Unstarred Question 1373 given in the Rajya Sabha on 4th August, 1994 and to state:

(a) whether some of the State Governments have made any representation regarding the non-availability of fertilisers;

(b) if so, the quota of supply to each State during 1993-94 and 1994-95; and

(c) the total demand of each State and to what extent the demand has been fulfilled?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILISERS (SHRI EDUARDO FALEIRO): (a) At present only urea is under statutory price and movement controls. Some of the State Government have, on occasions represented against temporary and localised shortages of Urea which have been made good,

(b) and (c) A statement giving the season-wise assessed demand of States as reflected in the allocations made under the Essential Commodities Act (ECA), availability and sales of Urea during 1993-94 and 1994-95 is in the Annexure, (See Appendix 172 (Annexure No. 31).
