# Harassment of Girl Students In Delhi University

1590. SHRI VIREN J. SHAH:

### SHRI PRAMOD MAHAJAN:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether Government's attention has been drawn to the report published in 'Hindiu stan Times' dated November 73, 1994 under the caption, Girl students don't feel safe in the lusty environment of Delhi University;
  - (b) if so, what are facts of the cases;
- (c) how many alleged sex related cases against the girl students and lady lecturers

have taken place during each of the last three years and so far in 1994;

- (d) in how many cases enquiries were instituted; the result of enquiry in each case and what action was taken against the persons found guily;
- (e) how far such cases in Delhi University have affected the serene atmosphere of the University particularly amongst the girl students in the pursuit of tension-free studies; and
- (f) what steps Government have taken or propose to take to stop this moral degradation and perversion and to safeguard the honour and dignity of the girl students and lady lecturers of the University?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. OF CULTURE) (KUMARI SELJA): (a) Yes, Sir.

- (b) The newspaper report in all mentioned four cases of sexual harassment of girl students/ lady teachers. According to the information furnished by the University of Delhi, there is no evidence of involvement of any Professor in the first case. In the second case, viz. Ramjas College ragging incident, the University has informed that the proctorial committee which examined the case did not establish stripping of any girl student. However, based on the findings, punitive action was taken against some students depending upon their involvement in the ragging incident. The University has also enacted an Ordinance for prohibition of ragging and for prescribing punishment for it. The third incident pertains to a particular college and as per information available with the University, the College has appointed a retired judge of High Court to inquire into the allegations. As regard<sup>8</sup> the last case, the Executive Council of the University has already imposed major penalty of reduction in rank on the concerned teacher and has also disqualified him from holding any administrative post.
- (c) and (d) The University has informed that no sex related case against girl students or lady teachers other than those mentioned in the newspaper report have come to the notice of the University.
- (e) and (0 According to the University\* the atmosphere is free from any sort of tension on this account and there is no moral degradation or perversion in the University.

## Smuggling of Rare Coins

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state :

- (a) whether CBI has recently unearthed a multicroro racket involved in the smuggling of rare coins and antiques with Nagpur as the centre for smuggling activity;
  - (b) If so, what are the details thereof;
- (c) what is the modus operandi of the racket involved in the smuggling of rare coins and antiques; and
- (d) what action has been taken by Government against those involved in the racket ?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. OF CULTURE) [KUMARI SELJA): (a) No such racket involved in the smuggling of rare coins and inriques with Nagpur as a major nodal point was unearthed. However, a complaint was referred to the CBI by the Archaeological Survey of India on 11-9-1991 relating to
