OF CULTURE, (KUMARI SELJA): (a) Baseline Studies were conducted as part of the project planning process of the District Primary Education Programme, in 46 districts spread over 8 States, to assess the present status of learning achievement levels at the primary level in these districts and to provide empirical bas's to the development of district plans under tak programme.

(b) The findings of these studies reveal that learning achievement levels are qui e low in several of these districts. The findings of the study have helped to define better the ralevent district level strategies.

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. OF CULTURE) (KUMARI SELJA): (a) and (b) Kendriya Vidyalaya Sangathan has intimated that it is yet to adopt the Central Civil Service (Representation of Service Association) Rules 1993.

(c) and (d) Kendriya Vidyalaya Sangathan has informed that the eligibility for continuing the recognition of the existing Associations will be considered based on the above Rules which are proposed to be adopted.

## Cost of construction of School Buildings

(b) There is no proposal under consideration of Ministry of Human Resource Development to entrust the construction of school buildings to private builders.

(c) and (d) The projects contemplated to be undertaken by the Society for Innovation and Development (SID) will be in the areas like Telecommunication. Manufacturing Processes, Food Processing, Software Engineering and Drug Design etc. These projects will be undertaken with the participation of industry, funding agencies and the Institute. The projects handled by the Centre for Scientific and Industrial Consultancy (CSIC) are small and medium projects directly under the Institute and hence the functions of the CSIC and SID will complement each other.
