People Living below Poverty Line

1894. SHRI RAJENDRA PRASAD MODY : Will the Minister of PLANNING AND PROGRAMME IMPLEMENTATION be pleased to state:

(a) what is the total percentage of India's population living be'ow poverty line on the basis of the report officially constituted Expert Group;

(b) whether there is any difference of opinion about the percentage of India's population living below poverty line between Government and the Expert Group;

(c) if so, the details thereof;

(d) the number of people living below poverty line in Rajasthan, with percentage; and

(e) the various steps taken by Government to reduce poverty and raise **the** income level of the people of India including Rajasthan ?

THE MINISTER OF STATE OF THE MINISTRY OF PLANNING AND PRO-GRAMME IMPLEMENTATION (SHRI GIRIDHAR GOMANGO): (a) The Expert Group on Estimation of Proportion and number of poor constituted by the Planning Commission estimated the persons below poverty line in 1987-88 as 39.34% for the country as a whole.

(b) and (c) The estimates of poverty made by the Expert Group differ from ihe Planning Commission estimates, mainly due to the difference in the methodology adopted. Planning Commission estimate of persons below poverty line in 1987-88 is 29.9% for the country.

(d) The number of people be?ow poverty line in Rajasthan estimated by Planning Comm'ssion is 9.95% million (24.4%) in 1987-88. The Expert Group on Estimation Proportion and Number of Poor estimated the same as 14.12 million (34.6%) in 1987-88.

(e) A number of programmes are being implemented in all the States, including Rajasthan in order to improve ths quality of life of the poor households. These include programmes for raising income and generating employment such as integrated Rural Development Programme (IRDP), Jawahar Rozgar Yojana (IRY), Nehru Rozgar Yojana (NRY) and Prime Minister's Rozgar Yojana (PMRY). Benefits to SCs/STs are specially earmarked in these programmes. In addition. Special Component Plan (SCP) and Tribal Sub-Plan (TSP) are being implemented which aim at providing a package of benefits for SC and ST families so as to enable them to meet their specific needs, raise their income and levels of livings.
