Increasing World-wide Demand for Tobacco

1815. SHRI GUNDAPPA KORWAR : Will the Minister of COMMERCE be pleased to state :

(a) whether it is a fact that Tobacco Board has noted that world-wide demand for tobacco is increasing every year;

(b) whether it is also a fact that world-wide demand for tobacco has increased at 2% per year during the last three years;

(c) whether the Tobacco Board has studied these trends;

(d) how does the Tobacco Board propose to evolve a strategy to take advantage of this increasing world-wide demand of tobacco ; and

(e) the details of any strategy formulated so far?

THE MINISTER OF COMMERCE (SHRI PRANAB MUKHERJEE): (a) and (b) Overall consumption of unmanufactured tobacco in the world has on an average increased by nearly 3.7% annually in the last three years ;

(c) to (e) Some of the measures being taken/proposed to be taken by the Tobacco Board in various areas include :

- (i) Reorienting production and developmental strategies in accordance with the changing international needs ;
- (ii) Enhancing quality and productivity levels of Indian tobacco and reducing its production cost to make it more price competitive in international markets ;
- (iii) Regular monitoring and strict control of pesticide residues;
- (iv) Encouraging grading by farmers in line with international grading systems.

iii) whether any plan or programme has been undertaken by TTCF for the improvement of productivity as well as profitability of Looksan Tea Gardens, and if so, what are the details in this regard ;

iii) if so, what action is being taken to increase the yield per hectare of the said garden and to improve its dilapidated plant and building conditions;

fc) whether any plan has been made to use the available land in the said garden for new plantations;

(d) whether it is a fact that Provident Fund contribution amounting to more than Rs. 10 lacs have not been deposited by M/s Tea Trading Corporation of India Ltd. (TTCI) for their Looksan Tea Unit in Jalpaiguri District (West Bengal) ;

fe) if so, whether it is also a fact that Provident Fund Authorities had to issue an order seizing the bank operations by the management of Looksan Tea Estate; and

ff) if so, the details thereof, and if not, the reasons therefor?

THE MINISTER OF COMMERCE (SHRI PRANAB MUKHERJEE) : (a) and (b) Following measures have been taken by Tea Trading Corporation of India Ltd. for improvement of production and profitability of Looksan Tea Estate :—

- (i) One new CTC machine has been installed.
- (ii) Plant and Machineries have been repaired.

(c) Tea Trading Corporation of India Ltd. has developed a nursery to cover another 5 hectares of areas under plantations in Looksan Tea Estate.

(d) to (f) No, Sir. The Provident Fund Authorities had issued order for seizure of bank operations of Looksan Tea Estate because of delay on the part of Tea Trading Corporation of India Ltd. to pay provident fund contributions. However, since the Corporation have cleared the arrears, these orders have been withdrawn.
