Targets and Achievements in Petroleum Sector

2381. SHRI K. M. KHAN : Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state :

(a) whether some production target for petroleum and natural gas was fixed for J 994-95;

(b) if so, details thereof with results of achievements made as on 30th November, 1994:

(c) whether Government propose to fix production target for Petroleum and Natural Gas for 1995-96;

(d) if so, details thereof with iteps to be taken in this regards;

(e) whether any target for import of crude has been fixed for 1995-96; and

(f) if so, details thereof with steps to reduce it in future?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (CAPT. SATISH SHARMA): (a) and (b) The target for crude oil production and natural gas sales during 1994-95 k about 32.30 million ton-r.en and about 15,000 million cubic metres, respectively. As against these targets the achievements during the period April-November, 1994 are about 20.98 million tonnes of crude oil and about 10.40U million cubic meters of natural gas.

(c) and (d) Targets for 1995-96 are jet to be fixed.

(e) and (f) The import plan for 1995-96 is yet to be finalised. To reduce imports Government have initiated a number of steps to augment indigenous production of crude, to promote conservation of petroleum products in various fields, to increase the refining capacity etc.

(a) whether it is a fact that the target fixed for drilling operations in respect of oil and natural gas in Himachal Pradesh could never be achieved in the prescribed time-schedule;

(b) what were the reasons for stopping the drilling of Changartalai-1 well without its completion which was targeted to be drilled upto 6000 meters, by Mahindra & Mahindra Company;

(c) whether it is also a fact that the rig used by the Mahindra and Mahindra Company was very old and that was declared useless by the French Company; and

(d) if so, what are the plans Government to get the drilling work completed in respect of oil and natural gas in Himachal Pradesh within its prescribed time-schedule;

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (CAPT. SATISH SHARMA): (a) and (b) No. Sir, However, drilling targets were not achieved in 1992-93 owing to the early termination of drilling in Changartalai-1. The drilling in Changartalai was stopped since the available data indicated adverse reservoir characteristics in the undrilled section.

(c) The rig was capable of drilling up to the target depth.

(d) As per the approved drilling plan, no activities are envisaged during the remaining part of VOT Plan.
