## Construction of a Building for CGIIS Dispensary at Janakpuri

- (b) if so, what facilities and services are likely to be provided to the CGHS beneficiaries in the new building; and
- (c) when the dispensary is likely to be shifted in the new building?
- THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHAN-KARANAND): (a) Yes, Sir.
- (b) The facilities to be provided in the new dispensary include morning and evening regular services and night Emergency services. It will also have a polyclinics providing Laboratory and some specialist OPD services.
- (c) The dispensary will be shifted to the new building after it is handed over to CGHS by C.P.W.D.

- (e) what action is being taken to eradicate of iodine deficiency cases in Arunachal Pradesh?
- THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHAN-KARANAND): (a) and (b) 63 million persons are estimated to be affecied by iodine deficiency disorders/goitre.
- (c) and (d) Tirap and Subansiri districts have higher incidence of deficiency disorders.
- (e) Steps have been taken to supply of iodised salt, financial assistance for establishment of IDD Cells, Survey, health education and publicity.

## Dismissal of Employees in the Central Council of Homoeopathy

Chandol, Office Superintendent was placed under suspension on 22-11-91. An enquiry against the charges framed against him was conducted and on receipt of inquiry report, Shri P. R. Chandol has been removed from the services of Central Council of Homoeopathy w.e.f. 22-10-93.
