1992 में शिक्षा प्रबंधन पर राष्ट्रीय परिप्रेक्य को बढ़ावा देने की दिशा में एक आवश्यक कदम के रूप में भारतीय शिक्षा सेवा (आई० ई० एस०) की स्थापना का प्रावधान किया गया है। इसमें यह भी प्रावधान किया गया है कि इस सेवा के बुनियादी सिद्धांतों, कायाँ और भर्ती की प्रक्रियाओं के संबंध में राज्य सरकारों के परामर्श से निर्णय लिया जाना चाहिए। तदनसार राज्यों से भारतीय शिक्षा सेवा के गठन पर अपनी विस्तृत टिप्पणियाँ भेजने का अनुरोध किया गया है । अब तक केवल गोवा, कर्नाटक, मध्य प्रदेश, पंजाब और पांडिचेरी एवं लक्षद्वीप संघ केंस प्रशासनों से ही टिप्पणियाँ प्राप्त हुई हैं।
