- (b) and (c) Based on the recommenda-tions of Prof. Yash Pal Committee Report, in June 1994 a broad framework of course

- action has been suggested to State/ UT Governments for adoption in all stages of school education. It includes suggestion for making provision of regulatory norms regarding pre-schools in the school education Acts/Rules and also for discontinuance of admission tests/interview and formal teaching of subjects at prechooling stages.
- (d) Total Literacy Campaigns under the National Literacy Mission constitute the principal strategy for imparting functional literacy to 100 million illiterates in the country by 1997. In Rajasthan, the total approved cost of ten literacy projects sanctioned is Rs. 13.37 crores out of which NLM share is Rs. 9.50 crores. In addition, two post literacy projects costing Rs. 5.44 crores have also been sanctioned. The NLM share for post literacy projects is Rs. 3.24 crores.

- (c) So far, an amount of Rs. 4919.88 lakhs has been released to the State Government of Gujarat for implementation of the Centrally Sponsored Scheme of Vocationalisation of Secondary Education at the +2 level,
