However, Universali-sation of Elementary Education, Non-formal Education for School drop-outs and Adult Education Progarmmes under the National Literacy Mission constitute the strategy for eradication of illiteracy. Under the National Literacy Mission, so far 29 Literacy Projects have been sanctioned covering fully 23 District and 6 Districts partly. In addition, 7 Post Literacy Projects have also been sanctioned-
