- (b) the number if such steel plants which have been closed down during the last one year; and
- (c) what steps Government are taking to help the secondary steel sector to survive?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SANTOSH MOHAN DEV): (a) to (c) The performance of mini steel plants (electric arc furnace units) has been affected due to various factors such as deman'd recession, shortage of power and increase in input costs including rise in international scrap prices. It is reported that 14 such units closed during the calendar year 1992 and another 15 units have closed during the calendar year 1993 (upto September, 1993). The Industry has represented for various reliefs and the proposals made are under the consideration of Government.

Private Sector Participation in Steel Industry

196. SHRI SURESH KALMADI: SHRI GOVINDRAO RAMRAO ADIK:

Will the Minister of STEEL be please'd to state:

- (a) whether it is a fact that greater private sector participation is being envisaged by Government in the steel industry;
- (b) if so, what are the reasons therefor; and
- (c) the details and the extent of private sector participation envisaged?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SANTOSH MOHAN DEV): (a) to (c) Due to resource constraints, it is not proposed to set up any new steel plant in the public sector during the VIII five year plan period. In order to bridge the projected gap in demand and availability, it is expected that additional steel production capacities will come up in the private sector. The iron and steel industry his been deregulated and also

exempted from the requirements of compulsory licencing. It is expected that finished steel production in the secondary steel sector will increase from about 6.70 million tonnes in 1992-93 to about 11 million tonnes in 1996-

Setting up Steel Plant in Public Sector

- 197. MISS SAROI KHAPARDE: Will the Minister of STEEL be pleased to state:
- (a) whether Government have taken a final decision to the effect that henceforth Steel Plants would not be set up in the public sector
 - (b) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SANTOSH MOHAN DEV): (a) and (b) In view of the limited availability of resources, there is no proposal to set up new steel plants is the public sector during the Eighth Plan Period. The resources available to the steel sector in the Eighth Plan are to be utilised for the modernisation and expansion of the existing steel plants in the public sector.

- (a) whether Steel Authority of India Limited (SAIL) has claimed an all round improvement in production during 1992-93;
- (b) whether it is also a fact that figures of production of saleable steel brought out by SAIL show that production in 1992-93 has actually come down in comparison to the period in 1991-92 over 1990-91; and
 - (c) if so, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SANTOSH MOHAN DEV): (a) Yes, Sir. SAIL Plants have shown all around improvement in production in 1992-93.
