(b) and (c) The National Nutrition Policy contains a comprehensive approach to tackle the problems of malnutrition and undernutrition in the country through a set of direct interventions and indirect policy instruments involving long term institutional and structural changes. The direct interventions include expanding the Social Safety Net, Fortification of essential foods, popularisation of low cost nutritious food and Control of Micro-Nutrient deficiencies amongst vulnerable groups. The indirect policy instruments are mainly aimed at provding food security, improving the dietary pattern through production and demonstration, improving the purchasing power and Public Distribution System, improving the status of women, ensuring enhanced participation community and developing nutritional -surveillance the system.

An Inter-Minkterial Coordination Committee under the Chairpersonship of Secretary (WCD) has already been constituted with representatives of concerned sectoral Ministries and experts on Nutrition as Members for monitoring and overseeing the implementation of National Nutrition Policy. The concerned sectoral Central Ministries have been requested for setting up of Special Working Groups in their respective Departments for analysing the nutritional considerations any relevance in their Sectoral Policies. Planning Commission has also been requested for setting up

National Nutrition Council. A request has also been made to the State Governments for setting up of State Level Apex Council with Chief Minister as its President and for setting up of special working groups in the related State Departments for monitoring the National Nutrition Policy.
