Joiist, Council of Vacational Education (JCVE) under the Chairmanship of Union Education Minister has been set up at the national level to ensure proper planning and coordination of the vocational programmes. A Central Institute for Vocational Edu--ation has been established in Bhopal as a national apex level research and development organisation for Vocational Education. A new Scheme of Pre-Vocational Education at Lower Secondary stage has been introduced during the current year. Sixty subject fields have been covered under the Apprentices Act to enable the students to avail of the benefit under the Apprenticeship Scheme. The recruitment rules for Group 'C and 'D' posts are being reviewed to make vocational pass-outs eligible for employment in Government/Qua'si Government jobs:

Discovery of Gold by Chitradurga Copper Company in Karnataka

(a) whether it is a fact that the Chitradurga Copper Company in Karnataka has found gold alongwith copper;

(b) what is the percentage of gold and whether it can be explored further ; and

(c) if so, what are the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF MINES (SHRI BALRAM SINGH YADAV): (a) Yes, Sir.

(b) and (c) Hutti Gold, Mines Co. Ltd. (HGML), an undertaking of State Gpvernment of Karnataka, which owns Chitradurga Copper Mine in Karnatika, has rsporteVl that preliminary analysis of some samples indicates that gold in copper ore varies from 0.1 to 15.60 gms/ton. HGML has indicated the need for further exploration.

Production of Copper

(d) whether Government are aware that the indigenous production of copper is likely to be almost static and the reasons therefor; and

(e) what steps Government have taken or propose to takee for copper exploration and expansion of existing mine and smelting capacity with, details thereof ?

THE MINISTER OF STATE OF THE MINISTRY OF MINES, (SHRI BALRAM SINGH YADAV): (a) to (c) Hindustan Copper, Limited, (HCL) is the only Central Gover.rjmenti. Public Sector Undertaking engaged in mining and production of primary copper, metal .in, the country. The indigenous production of refinelS copper meets about 30-35% ,of the demand of copper in the country. With the available and known ore reserves, it is not possible to be sufficient in copper through indigenou" production in the near future. The gap between the demand and the indigenous production is met through,,imports which are allowed freely under the current import policy.

(d) The indigenius production of primary copper metal is not likely to improve due to poor grade of ore, limited known reserves of copper ore in the country. lowscale of operations, high input costs, etc.

(e) Geological Survey of India (GSI), a Subordinate Office of Ministry of Mines is responsible for regional exptoratiin for minerals and Mineral Exploration Corporation Ltd. (MEGL), a Central Government Public Sector Undertaking under the administrative control of Ministry of Mines is
