Team which visited Bihar in October, 1992, the Govt, of India released an amount of *Rs.* 19.6750 crores to the State Government as advance from the CRF apart from Rs. 75.00 crores from Jawahar Rozgar Yojana and Rs. 3.47 crores from Accelerated Rural Water Supply Programme. The Government of India also made additional allocation of wheat and rice specifically for the drought-affected areas.

Full-time lecturers lor vocational courses

- *140. SHRI PRAGADA KOTAIAH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased *to* state:
- (a) whether representations have been received requesting Government to per. mit appointment of full time lecturers in the vocational courses run by various colleges, instead of part-time lecturers; and
 - (b) if so, he decision taken in this matter?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) A representation was received from Andhra Pradesh State Vocational Education Teachers Association in October 1992 which was sent to the State Govtrnment for consideration and action at their level.

(b) The Centrally Sponsored Scheme of *Vocationalisation of Secondary Education' does not provide for part-time teachers to become full time teachers. It is, therefore, for the State Government to take an appropriate decision on this representation.

Performance of farm universities

- 1047. SHRI KRISHAN LAL SHARMA: Will the Minister of AGRICULTURE be pleased to state;
- (a) the names of the committee which have been set up by Government to evaluate the performance of the various farm universities in the country;

- (b) when these committees were set up and whether any reports were submitted by each committee so far and expenditure incurred thereon separately; and
- (c) the reaction of Government on the recommendations made by these Committees?

THE MINISTER OF STATE IN THE MINISTRY OF NON-CONVENTIONAL ENERGY SOURCES AND THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI S. KRISHNA KUMAR): (a) The Central Government /IGAR appointed an Agricultural University Review Committee (generally referred to as the Randhawa Committee) to evaluate the performance of various Agricultural Universities of the country.

- (b) The Randhawa Committee was see up in January 1977 and its report was submitted in June, 1978. No separate establishment was set up for the Committee and the expenditure incurred was only on the TA. and D.A. of the Committee Members.
- (c) The Central Government/ICAR have accepted all the major recommendations of the committee and have implemented those pertaining to the Central Government. Furthsr, the respective State Government's and the Agricultural Universities were requested to implement the recommendations concerning them.
