NATH RAD: (a) and (b) Food Corporation of India does not procure groundnut. It procures wheat and coarsegrains in Gujarat under price support scheme. The procurement of coarse grain/wheat in Gujarat is undertaken through Gujarat State Cooperative Marketing Federation Limited, Gujarat which operated 53 centres for procurement of wheat and coarsegrain during rabi 1993-94;

(c) and (d) No request has been received to open purchase centres for procurement of groundnut in Gujarat. However, the State Government of Gujarat has requested to undertake procurement of coarsegrain in current kharif marketing season-1993-94 FCI has made necessary arrangement in this regard 三劉訓

Implementation of Integrated Child Development Scheme in Orissa

- (d) what are the names of State Government's which have not informed the Centre so far about the allocations made by them in this regard; and

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT) (SMT. BASAVA RAJESWARI): (a) No, Sir.

- (b) 218 Central Sector Integrated Child Development Services (ICDS) Projects have been sanctioned in the State of Orissa. Of them, 176 projects are already operational.
- (c) For implementation of the ICDS Programme in the country, the following provisions exist:—
 - (i) VIII Five Year Plan Rs. 1615.74 crores.
 - (ii) 1993-94 Plan . . Rs. 473.88 crores.

No State-wise allocations have been made. Government of Orissa has intimated that they have provided a budget of Rs. 49.81 crores for the programme for 1993-94.

(d) and (e) The Department is regularly monitoring the provision of supplementary nutrition to ICDS beneficiaries under the ICDS Scheme. 28 States/UTs have already intimated the Department on provision of funds for nutrition in their State Budget during the current year. This information is yet to be received from 4 States, viz. Himachal Pradesh, Manipur, Nagaland and Sikkim which have been requested for expediting this information.
