Regular inspections of Super Bazar Branches

*141: SHRI GOPALSINH G. SOLANKI: Will the Minister of CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether there is any provision to conduct regular inspections of the branches of the Super Bazar;
- (b) if so, the details of such inspections carried out during the last three years in each branch including the Main branch and control room;
- (c) nature of irregularities detected and the action taken against those found guilty;
- (d) whether cases of the gross irregularities have also come to the notice of Government;
- (e) if so, the corrective steps taken or proposed to be taken by Government to remedy the situation; and
 - (f) if not, the reasons therefor?

THE MINISTER OF CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI A. K ANTONY):
(a) to (f) Inspection of branches and other areas of Super Bazar including the main branch are carried out from time to time by the General Manager and other Officers of Super Bazar. Inspection of branches and mobile vans are also conducted on regular basis by certain specified Inspecting Officers. The details of inspection conducted by the Inspecting Officers during the last three

Super Bazar has reported that irregularities like stock shortages, overcharging, theft and mis-appropriation and mis-demeanour have been detected. Disciplinary action by way of imposition of major and minor penalties regarding removal and dismissal from service, demotion, reduction in grade, Censure, warning, stoppage of increments etc. recovery from salary for stock shortages and administrative action by way of transference, is taken against erring officials. Cases of gross irregularities are also referred to the police. In addition Management of Super Bazar also take corrective steps to ensure that such irregularities do not recur.
