SHRI SUSHILKUMAR SAMBHA-JIRAO SHINDE:

#### SHRIMATI VEENA VERMA:

Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether Government's attention has been drawn to a study published in the 'Hindustan Times' dated 27th September, 1993 on 'TV-Impact on the growth of children" in the context of multiplicity of TV-Programmes available and the growing reliance TV programme and feature films shown on TV placed on sex and violence as important ingredients of success formula; and
- (b) if so, the steps being taken by Government to prevent the adverse impact of TV programmes on the children and on the posterity?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI K. P. SINGH DEO): (a) Yes, Sir.

(b) Regulation of the exposure of children to television can only be undertaken by their parents/guardians and not by the Government.

THE MINISTER OF STATE IN THE MINISTRY OF POWER (SHRI P. V. RANGAYYA NAIDU): (a) Yes, Sir.

- (!) and *(c)* The National Thermal Power Corporation is establishing the Kahalgaon Thernial Power Project in Bihar in the Central Sector which would supply power 10 all the states in the Region.

## **Increase in Power Tariff in Gujarat**

- (a) whether the increase in power tariff has greatly affected the farmers of Gujarat;

- (d) to what extent the demands were accepted?

THE MINISTER OF STATE IN THE MINISTRY OF POWER (SHRI P. V. RANGAYYA NAIDU): (a) Even after the recent increase in tariff, which was effected after a period of 6 years, the average rate of realisation from agricultural sector in Gujarat comes to about Rs. 39.61/kwh only.
