(a) what are the details of goods confiscated at Bombay and Delhi Airport during the last three years year-wise; and

(b) what are the names of the firms/companies whose goods have been confiscated alongwith the value of the goods ?

### Increase in Limit for Gujarat by R.B.I

1451. SHRI AHMED MOHAMMED BHAI PATEL : Will the Minister of FINANCE be pleased to state :

(a) whether Reserve Bank of India (RBI) has raised the limit of ways and means provisions for the State of Gujarat;

(b) if so, what is the new limit set;

(c) to what extent it is more in comparison to earlier provisions;

(d) to what extent it will be helpful;

(e) whether the ratio instead of improving had declined in Gujarat;

(f) whether State Government of Gujarat had pleaded for floating a bank in the joint sectors; and

(g) if so, whether the R.B.I. has taken a final decision in this regard ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI M. V. CHANDRASHEKHAR MURTHY) : (a) Yes, Sir. R.B.I. has raised the limits for Ways and Means advance, both normal and special, for all the State Governments, banking with them including Govt. of Gujarat with effect from 1-11-1993.

(b) and (c) In respect of Gujarat, the pre-revised and the revised limits for normal and special Ways & Means (W&M) advance alongwith the increases resulted by the above revision are as under :—

(d) The revised limits of Ways & Means advance are expected to help all the State Governments banking with R.B.I. including Government of Gujarat in better management of their finances and avoiding overdraft.

(e) to (g) Information is being collected and will be furnished.

### Release of Budgetary Support to the Central Sector

1452. SHRIMATI KAMLA SINHA : Will the Minister of FINANCE be pleased to state :

(a) whether it is a fact that Government have further deferred the release of the promised budgetary support to the central sector until the last quarter of 1993-94;

(b) whether it is a fact that this has created serious problems for the fund starved energy and transport sectors, and also those sectors which are wholly dependent on budgetary support such as moral development, and health and social services; and

(c) if so, what steps Government propose to take to ease the financial pressure of these priority sectors ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI M. V. CHANDRASHEKHAR MURTHY) : (a) and (b) No, Sir. As a part of normal cash management certain payments were deferred for a short period in June, 1993.
