- (b) if so, what are the salient features of the report?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI K. P. SINGH DEO): (a) and (b) The High Level Committee set up by the Government to study the aspects relating to the services and cadres of all the media units and organisations of the Ministry of Information and Broadcasting and suggest remedial measures, did not include the only public Sector Undertaking, i.e. National Film Development Corporation under this Ministry, within the purview of its study.

The Salient features of the Report of the Committee relate to services and cadres under the Ministry of I&B and reorganisation of its various media units, training of the personnel and delegation of administralive and financial powers.
