(b) Six high level Indo-Pakistan Bilateral Meetings have been held since 1975. The last meeting was held at Islamabad on 8-9 June, 1988. Keeping in view the seriousness of locust situation, frequency of border meetings was increased and during the period from June to November, 1993, ten border meetings of the Indo-Pakistan locust officers were held to discuss locust situation and control operations in both the countries.

The following international assistance has been received through FAO so far:—

- (i) 15 High Frequency (HF) Radio
- (ii) 20.2 MT of fenitrothion ULV.
 - (iii) 100 hand held battery operated MICRO-ULVA sprayers.
 - (iv) 8ULVA-MAST, Vehicle mounted sprayers.

KRISH NA KUMAR): (a) The adoption of Integrated Pest Management approach had enabled the farmers to reduce the consumption of chemical pesticides in many countries.

(b) and (c) In order to minimise the use of chemical pesticides the Government is promoting Integrated Pest Management technology wherein it is advocated that chemical pesticides should be used as a last resert on the basis of economic threshold level of pests.
