Law and Order Situation in Nagalanu

2871. SHRI VIZOL: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that State Government of Nagaland is in connivance with certain underground forces against. another forces leading to killing of many innocent people every day in Nagaland and damaging large number of properties;
- (b) whether it is also a fact that in certain areas of Manipur inhabited by Naga people, Kuki National Army supported Government of Manipur are fighting with Naga Militants;
- (c) whether it is also a fact that with such State of affairs several villages have been razed to the ground with State Government of Manipur watching only;
- (d) whether such situation as in (a) and (b) in Nagaland has created discontentment amongst the people of Nagaland and has led to serious law and order problem and the situation has become out of control;
- (e) whether Government propose to take some measures to ensure proper functioning of law and order in Nagaland providing foil security to people and their properties as well; and
- (f) if so, details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. M. SAYEED): (a) There are no such reports.

- (c) A number of villages have been affected by arson in some districts of Manipur in the on-going Naga-Kuki clashes. The Central Government has deployed more units of security forces to help the State Government of Manipur. With this deployment, there has been a decline in the number of incidents and casualities in the months of October and November, 1993 as compared to the month of September, 1993.
 - (d) No, Sir.

(e) and (f) With a view to assist the State Government, the Central Government has provided special assistance amounting to Rs. 7.40 crores for strengthening the State Police Force.
