# **NUTRITION PROGRAMME IN THE STATES**

3378. **SHRI RAJENDRA PRASAD MODY** : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether Government propose to launch some nutrition programme in some States;

(b) if so, any nutrition programme has been launched in Rajasthan; and

(c) if not, the reasons therefor ?

THE MINISTER OF STATE OF THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT) (SHRIMATI BASAVA RAJESWARI) : (a) No new nutrition programme is being launched. However, there is a proposal to expand the Integrated Child Development Services Scheme (ICDS), under which supplementary nutrition is provided to children upto 6 years of age, pregnant women and nursing mothers.

(b) and (c) Under ICDS Scheme, 153 projects have been sanctioned in the State of Rajasthan. And, as on 30-9-93, 6.46 lakh children and 1.12 lakh pregnant women and nursing mothers are being provided with supplementary nutrition in Rajasthan. Further, Adolescent Girls Scheme which envisages provision of supplementary nutrition as a vital input, has been sanctioned in 24 projects in Rajasthan. In addition, 200 Balwadi Centres under the Balwadi Nutrition Programme and 500 Creches under Scheme of Creches/Day-Care Centres are providing supplementary nutrition to 8000 (3—6 years) and 12500 children (upto 5 years of age) respectively in the State of Rajasthan.
