**RE. ... CONCERN OVER LIKELY WINDING UP OF THE JAIN COMMISSION OF INQUIRY**

**SHRIMATI JAYANTHI NATARAJAN (Tamil Nadu):** Madam, I would like to draw the attention of the House and of the Government, through you, to an extremely disturbing development that has taken place. It is with a sense of great shame and great regret that I am getting up to draw the attention of his House to this incident.

On Friday, the 20th, we will be observing the 49th birth anniversary of our late, revered leader, Shri Rajiv Gandhi. All over the country millions of our countrymen who loved him and still deeply mourn his passing away, will pay solemn tributes to his memory.

But in grim contrast, in grim irony, Delhi the Jain Commission of Inquiry will be winding up the inquiry because of non-cooperation, according to the Judge.

**SHRI SATYA PRAKASH MALAVIYA (Uttar Pradesh):** Non-cooperation by whom?

**SHRI MENTAY PADMANABHAM (Andhra Pradesh):** By the Government. ... (Interruptions)

**SHRI MENTAY PADMANABHAM:** It is not fair.
