SATISH SHARMA); (a) Applications are presently being invited by the Oil Marketing Companies for selection of RO dealers through the Oil Selection Boards against the vecancies pending from previous marketing plans and 997 proposals from the current marketing plan for 1988-93.

(b) 53 and 186 RO dealerships are planned for Gujarat and Bihar respectively in the current marketing plan.

(c) In order to expedite the selection of dealers. Government have consistuted State/

Region-wise Oil Selection Boards including those for Gujarat and Bihar.

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) A scheme of pollution abatement of river Yamuna, called the Yamuna Action Plan, has been launched by the Government Under this plan, pollution abatement works are to be taken up in six towns of Haryana and eight towns of Uttar Pradesh besides Delhi The works would include (0 interception and diversion of municipal waste water from these towns, (ii) treatment of such intercepted waste water, (iii) setting up of facilities like low cost sanitation, improved cermatoria, river front development, etc. and (iv) plantation along the river bank. Work on the Action Plan has begun.

(b) Aspects such as reclamation of land from river bed and development of tourism infrastructure are not covered under the Yamuna Action Plan.
